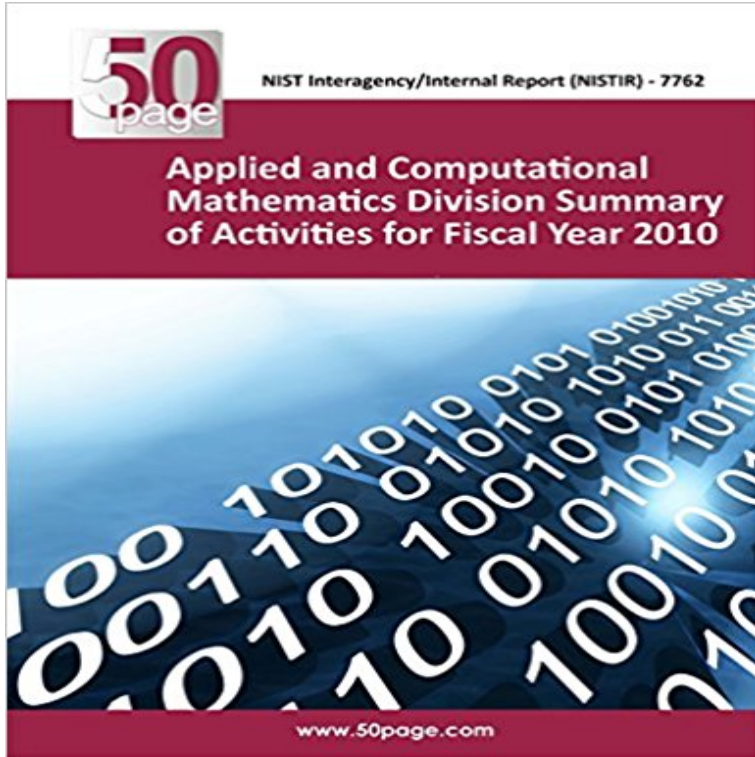


Applied and Computational Mathematics Division Summary of Activities for Fiscal Year 2010
